1. General specification

Scope of Document

These operating instructions are valid for all POS-PRO monitors up to a maximum screen diagonal of 39.6 cm (15.6"). POS-PRO monitors are available in different screen diagonals, with different integrated controllers and additional options. Note: These operating instructions may be supplemented by other documents in which the operation of the various controllers is described in detail. Please refer to the relevant notes. - POS-VP-PRO: Monitor with integrated network media player for video playlists

4. General Safety Regulations

Safety information

Please read this safety information carefully for your personal safety and for the prevention of property damage.

In case of a malfunction, immediately disconnect the power plug and contact your dealer or the next Distec GmbH service centre. A malfunction is also considered if the housing, a control element or cable is damaged or if liquids or other objects penetrate the monitor.

Please read the safety information carefully before installing the device. If you have any doubts about whether the device may be used in a particular environment, please contact our service partner.

Repairs

Repairs may only be carried out by authorized technical personnel. Unauthorized access or improper repairs might cause serious property damage or cause danger to the user. In addition to that, any legitimate warranty claim expires.

Electrical connection

Disconnect the monitor from socket before executing any work. Do not touch or connect data cables or power cables during thunderstorms.

System start-up

Before the system start-up let the monitor adjust to the room temperature. Do not expose the device to direct heat sources. In case of condensation, please wait a minimum of 12 hours before switching on the monitor. The monitor shall only be installed and used according to this documentation data sheets. Only qualified personnel may perform the initial installation and system setup.

Qualified personnel

Qualified personnel, in terms of the safety information of this documentation, are persons who are qualified to activate, ground and label devices, systems and circuits according to the safety standards.

Operation

For a proper and safe utilization of the product, adequate transportation, storage, installation, assembly, careful handling and maintenance are essential. The device is only certified for in-door operation. Extreme ambient conditions shall be avoided and the monitor shall be protected from dust, humidity and heat. Do not expose the monitor to direct sunlight.

Transport

Unpack the monitor at the place of installation. Use only original packaging for transportation. Please observe these rules for any later transport.

Condensation

Avoid condensation during transport at low temperatures or at extreme fluctuations of temperature.





- → If the device is not used for a long period of time, unplug the power cable.
- → Do not unplug the power cable while the device is powerd on, except for emergencies.
- → To unplug the device without problems, sockets have to be easily accessible.
- \rightarrow Ensure that the power cable does not get pinched or kinked.
- \rightarrow Do not place heavy objects on the power cable.
- → Do not use damaged or loose sockets to plug in the device.
- → Plug the device in earthed sockets only.
- → Operate the device with the power cables included in the delivery packet only.
- → Use undamaged power cables only.
- \rightarrow When plugging in and out, do not touch the power cable with wet hands.
- → Ensure that the power cable is plugged in the socket safely and correctly.
- → Use for devices with external power supply only the supplied original power supply, or an equivalent Low Power Source (LPS).
- → Do not use extension block to plug several devices into a single socket.



- → Put down the device slowly and carefully to avoid damaging the LCD screen. Ensure that the device stands stable.
- → Keep packaging away from children. Danger of suffocation!
- \rightarrow Use our specified and professionally mounted wall mounting only.



- \rightarrow Do not put objects onto the device.
- → Do not place candles, heaters or humidifier near the device.
- → Keep the device away from fireplaces and flammable materials.





General Safety Regulations





- → Ensure sufficient ventilation of the device.
- → Keep a minimum distance of at least 10 mm devices to the wall, for devices with integrated PC of at least 40 mm.
- \rightarrow Ensure compliance with the operating temperature.
- → Do not install the device in places where it is exposed to environmental impacts such as rain or direct sunlight.
- → Do not install the device in places where it is exposed to high humidity, dust or smoke. In case of doubt, please contact your sales partner.



- → Please use a soft, moist cloth for cleaning.
- → For cleaning the screen, please use only commercially available screen cleaner. Do not spray the cleaner directly to the device but onto a cloth.
- → Please clean ventilation slots regularly to ensure a good air circulation.
- → Protect your device from water splash.
- → When cleaning, please make sure that no liquids get into the device.
- → Screens and surfaces can be easily scratched. Therefore, please use the prescribed cloth only.



- → Attention! High voltage! Never open the device by yourself.
- → In case of unusual noises, burnt smell or smoke unplug the power cable.
- \rightarrow Do not insert objects into the device through the ventilation slots.
- → If the same picture is displayed over a longer period of time, an after-image may arise.
- → When exchanging batteries of the remote control, pay attention to the polarity. Keep batteries away from children and ensure an environmentally correct disposal.

5. First Installation

Position of connectors and controls

The connection elements for the power supply and data cable are located at the bottom on the back of the monitor. The POS-RP-PRO and POS-MO-PRO series have a keypad for the monitor settings. This keypad is located on the right on the back of the monitor.

Mounting with VESA compatible brackets



The POS-PRO monitors have an integrated VESA mount.

The operating position of the device is vertical (90° to the floor). The permissible tilt angle must be observed for wall mounting.

The device can be operated both in landscape mode and in portrait mode.

Mounting

Distance to wall:

- Devices without PC: min. 10 mm
- Devices with PC: min. 40 mm



Permitted tilt angle for mounting

The monitors may only be mounted with a tilt angle of 0° - +180°.



Connecting to power



Note: POS-PRO monitors require different operating voltages depending on the equipment and version. Please observe the information on the correct operating voltage on the type plate before connecting the monitor to a power supply.

Note: POS-PRO monitors can be supplied with a suitable power supply unit from our accessories shop. Please follow the instructions in the section "Connecting the power supply to an existing power source".

Connecting the power supply with optional power supply unit

Note: Connect all data cables to the respective external devices before connecting the power supply to the monitor.

An adapter cable for connecting the optional power supply unit to the monitor is included with all monitors.

- \rightarrow Plug the adapter cable into the monitor.
- → Connect the adapter cable to the 12V cable of the desktop power supply unit.
- → Connect the power cable to the desktop power supply unit.
- → Plug the power cable into a suitable socket.
- → Disconnecting device: The AC desktop power supply can be disconnected via the Phoenix plug (DC) on the POS-Line V2 monitor or via the Schuko plug of the AC power supply.



Connecting the power supply to an existing power source

Caution: POS-PRO monitors with an input voltage of 12V or 24V may only be operated with a current source of limited power (see standard EN 62368-1, chapter 2.5, table 2B "Current source limited line" with max. 12V/8A/ or 24V/4A 100VA).

- → Make sure that your power source has sufficient power. Please refer to the rating plate or data sheet for the maximum power consumption of the monitor.
- → If necessary, disconnect the adapter cable from the device and the power supply unit.
- → Disconnect the green phoenix plug from the adapter cable.
 - ▲ → Connect the power supply to the Phoenix plug, observing the correct polarity.
 - \rightarrow Phoenix plug, observing the correct polarity.



 \rightarrow Connect the Phoenix plug to the device.

→ Disconnecting device: The DC supply network can be disconnected via the Phoenix plug on the POS-Line V2 monitor.

6. Touch Sensors

POS-PRO monitors are equipped with a touch sensor. The PCAP touches used are water, palm and 10-finger compatible. The touch is already mounted at the factory and the drivers are installed.

POS-RP-PRO and POR-IQ-PRO:

The required drivers are already pre-installed in these monitors. The touch can be put into operation immediately.

7. Mounting optional installation frame

Note: POS-PRO monitors can be supplied with a suitable mounting frame from our accessories shop. Below you will find information on the mounting options.

There are two basic options for mounting using the mounting frame:

1. mounting from the front with snap-in bracket

2. mounting from the rear with M4x12 spacer bolts and M4 screws, no snap-in solution

Passive Cooling

POS-IQ-PRO series monitors are equipped with passive cooling.

Passively cooled monitors dissipate the heat from the processor to the monitor housing. Passively cooled devices have no moving parts.

Calling up the BIOS settings

The Integrated iBASE PC is equipped with a BIOS from American Megatrends Inc (AMI BIOS). When switching on the PC, press the ,DEL' or ,Del' key on the keyboard to access the BIOS.

The BIOS is secured with a password. You will receive the password in the device box on delivery.

Operating systems

If you have ordered the POS-IQ-PRO with the Windows operating system option, the operating system you have ordered is already pre-installed. All necessary drivers have also been installed.

A distinction is made when activating the operating system:

- → Windows 10 IOT: The operating system is already activated. The licence key is stuck to the monitor.
- → Windows 10 PRO: The operating system is not activated. The licence key is enclosed. When you switch on the device for the first time, you will be prompted to enter the licence key.

Configuration of the media player on delivery (factory configuration)

This device is a LAN (Ethernet)-capable device. Please note that an incorrect network configuration of the device can impair the secure operation of the entire network and, in the worst case, lead to a network failure. To set up the device for a specific network, you must be familiar with the main operating parameters of the network.

POS-Line VideoPosters are supplied from the factory with the following configuration:

- → DHCP: on
- → IP address: Assigned by the DHCP server (static IP address 192.168.0.1 if there is no DHCP server in the network)
- → Netmask: Assigned by the DHCP server (255.255.255.0 if there is no DHCP server in the network)
- → Hostname: VideoPoster-IV-xx-xx (the last 6 bytes of the MAC address of the device)
- → Login name: Artista
- → Password: Artista
- → Content auto update: off

MicroSD card

The media player stores its playlists on the internal 32 GB memory. However, this can be expanded using a microSD card if the internal memory is not sufficient. If a microSD card is inserted, it must not be removed during operation!

Supported media formats

- → MPEG-4 AVC / H.264

General function description

The network-compatible media player is a complete solution for playing playlists. The playlists are based on an XML structure and can contain images and videos. The media player is controlled entirely via the playlist; a loaded playlist is played in an endless loop. A playlist can contain several sub-playlists, each of which is time-controlled or called up by an external trigger event.

The media player does not need to be "operated". As soon as a playlist has been fully loaded, it is played automatically. The device can be disconnected from the power supply at any time. When it is switched on again, the last loaded playlist is started automatically.

Priority-controlled external feed

An external playback device, e.g. a BlueRay player, can be connected to the HDMI interface of the media player. The playback control can be set up so that playback of the playlist is stopped as soon as an HDMI signal is recognised. In this case, the signal received via HDMI is played back. If the HDMI signal is switched off, the player automatically starts playing the saved playlist.

Software

You have been provided with the following software and the associated documentation by e-mail:

ACC: A programme that runs under Windows for easy creation of playlists, for transferring playlists to the media player, for saving playlists on a USB stick (for manual transfer) and for monitoring the operation of the media players.

ADF: A programme that simplifies the installation and configuration of media players. Connect all media players in the factory configuration to the network and start ADF. All media players are displayed in a list. Select the devices one after the other and carry out the network configuration.

Load playlists

There are basically four possible methods for loading playlists:

Via USB: If a USB stick with a playlist is inserted into the media player, it is automatically loaded and started. A network connection is not necessary in this operating mode.

Via ACC: This Windows software included in the scope of delivery creates the playlists and offers functions for transferring the playlists directly to one or more media players via the network.

Via FTP server: The media player connects to an FTP server at configurable time intervals and searches for a new playlist. The difference between the existing and new playlist is automatically reloaded and the new playlist is started.

Via HTTP protocol: Playlists can be transferred from a content management system to the media player via the network using the HTTP protocol.

Configuration of media player

The media player can be configured using any standard Internet browser (Firefox, Internet Explorer, Chrome, etc.). To do this, connect the media player to a network and enter the URL (e.g. IP address or network name) in the browser to establish the connection. The WEB interface will now open. If you are asked for the password, enter the password (factory setting: Login name: Artista; Password: Artista).

The web interface is divided into three areas with the respective pages:

Configuration

Network configuration:	: Configuring the network is the first step in the setup process. With "Submit Configuration" the entries are accepted. With "Discard Changes" entries in the fields are deleted, but this has no effect on the current configuration.
Date and time:	Set the time zone, date and time here. The time can be automatically synchronised with a network server (NTP).
Content auto update:	Enter the access data for an FTP server here if you want the media player to automatically should load its playlists from an FTP server.
Audio settings:	You can set the volume for external speakers here.
Display settings:	You can set the display brightness here.
HTTP Access:	You can assign a new password here. It is recommended to change the password after installation.
Advanced:	On this page, you can update the firmware, reformat the microSD card (optional), reset the module to the factory settings with a master reset and factory settings with a master reset and enable the priority-controlled HDMI input.

Advertisement of IP address and host name

When the media player boots up, the current IP address and the host name of the media player are displayed on the screen for approx. 5 seconds.

11. POS-WP-PRO WebPoster

Connections and controls

WebPosters are POS-RP-PRO devices with a special firmware, therefore the connections and operating elements in the corresponding section must be observed. Connecting a mouse and keyboard is not supported with this firmware.

General function description

The Industrial Full HD HTML Player is a complete solution for displaying websites. The web pages can be configured via a web interface. An automatic display takes place when the device is started.

Configuration of the media player on delivery (factory configuration)

This device is a LAN (Ethernet)-capable device. Please note that an incorrect network configuration of the device can impair the secure operation of the entire network and, in the worst case, lead to a network failure. To set up the device for a specific network, you must be familiar with the main operating parameters of the network. The POS-Line WebPoster is delivered from the factory with the following configuration:

- → Host name: WebPoster-xx-xx-xx (the last 6 bytes of the MAC address of the device)

ADF: A programme that simplifies the installation and configuration of HTML players. Connect all HTML players in the factory configuration to the network and start ADF. All HTML players are displayed in a list. Select the devices one after the other and carry out the network configuration.

Configuration of media player

The HTML player can be configured using any standard Internet browser (Firefox, Internet Explorer, Chrome, etc.). To do this, connect the HTML player to a network and enter the URL (e.g. IP address or network name) in the browser to establish the connection. The WEB interface will now open. If you are asked for the password, enter the password (factory setting: Login name: Artista; Password: Artista).

When the HTML player boots up, the current IP address and the host name of the HTML player are displayed on the screen for approx. 5 seconds.

Switch On or Off

The POS-RP-PRO monitor starts automatically when the supply voltage is applied. To switch off, "Shut down" must be selected in the operating system.

Operation systems

The POS-RP-PRO Monitor is supplied with the Raspbian operating system, which is equipped with all the necessary drivers. This operating system is the official version of the community, reduced to the internal memory of the compute module. It is only used for the initial commissioning of the monitors. The POS-RP-PRO monitor can be equipped and programmed with its own operating system/image by the customer. The USB port on the back of the monitor, which is located under the cover, can be used for this purpose (see arrow).

13. Maintenance

For devices with active cooling, the ventilation slots of the housing must be cleaned every 6 months to ensure sufficient air circulation. For devices with passive cooling, the ventilation slots must be checked every 12 months and cleaned if necessary.

14. Warranty / Service

Warranty

FORTEC GROUP grants a manufacturer's warranty of two years from the date of delivery.

During the warranty period, FORTEC GROUP shall repair product faults based on material or production defects. Warranty claims are only accepted, if FORTEC GROUP receives notification of a defective product within the warranty period and the product is presented to the FORTEC GROUP Service Centre together with all information as specified in the RMA process.

Display Quality - Prevention of after image burn in effects

After image burn-in means that an image or part of an image (i.e. logo) remains visible on the screen even if the image on the screen is changed. This should not occur if the LCD panel is operated in normal conditions with changing content. To prevent burn-in effects please follow the following guidelines.

- → Power-off the monitor for 2 hours after using it for 18 hours.
- → Use the power scheme and power management of the PC.
- → Use plain-colored screen savers.
- \rightarrow Avoid patterns with a strong difference in brightness and contrast.
- → Avoid gray colors.
- → Change images and logos regularly. Show animated pictures for 60 seconds after 4 hours of operation.
- \rightarrow The best way to protect your display is to switch the monitor off when not in use or to use screen savers.

Non-observance of these guidelines may have effects on warranty.
